- ❑ ILPA Summit events are not a fit for real estate-focused funds or real asset focused funds, very niche strategy focused funds or niche geographically focused funds are also typically accepted for participation at the Summit as we need to ensure that there is a match with the typical base of limited partner attendees.
- ❑ The manager applications that are focused on private equity, buyout, growth, private credit, secondaries and some venture capital are more representative of the GP participants at the Summit. Applications for strategies outside of the ones listed are not a fit as we want to ensure that we can build out a full schedule for selected GP participants.

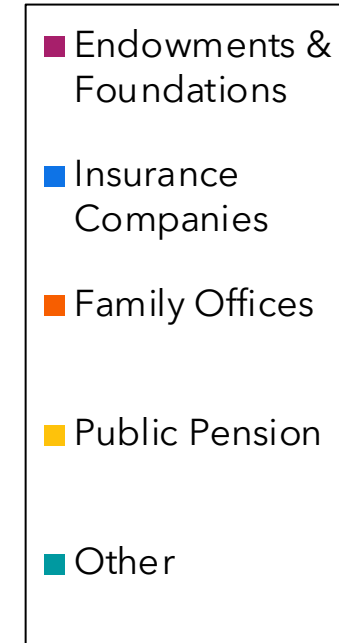
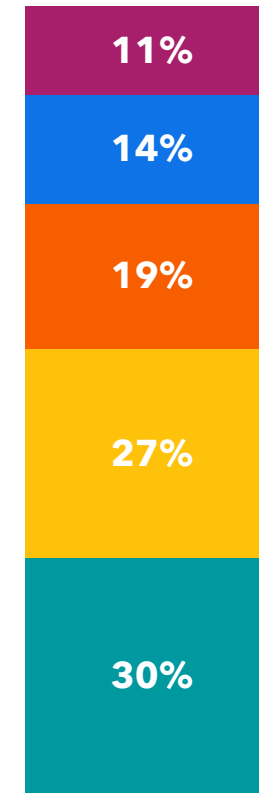
Summit Europe Attendee Profiles By Institution: Diverse Strategies, Diverse Allocators

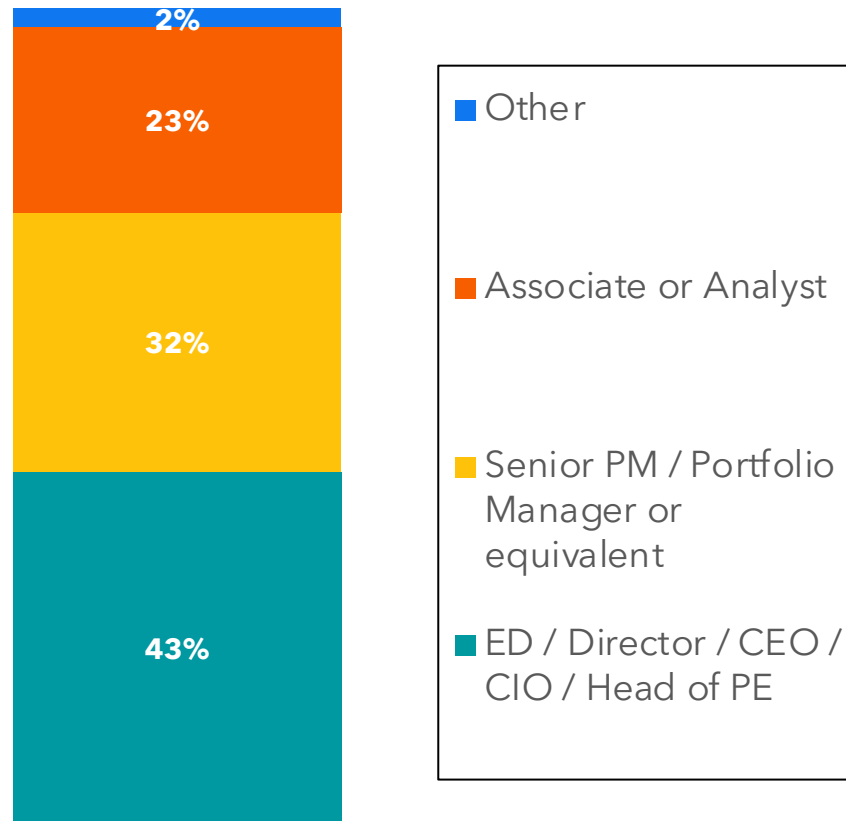

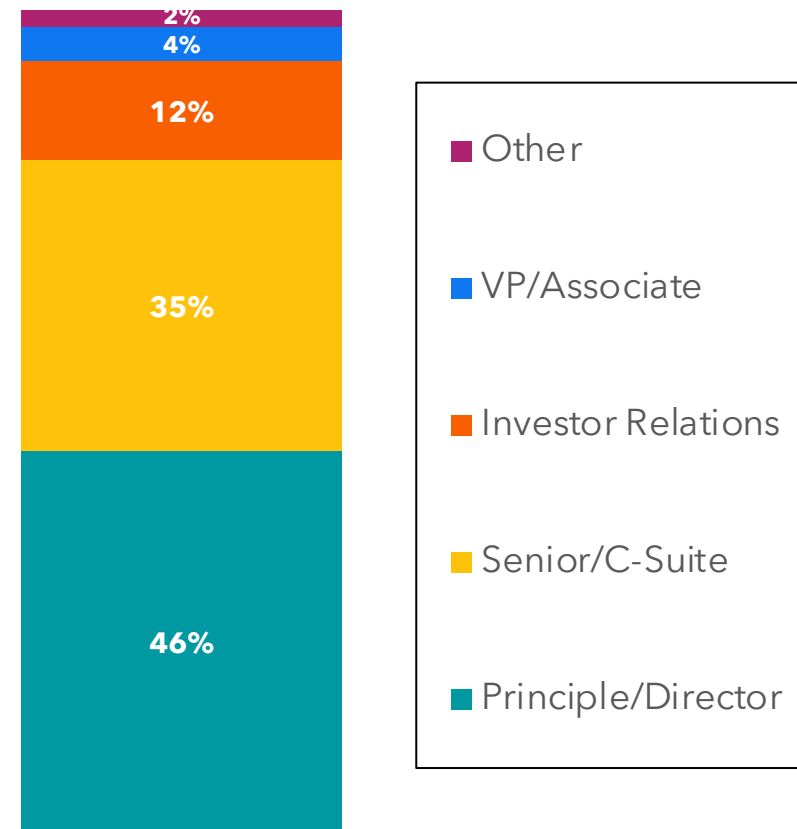
Summit Europe Attendee Profile By Role: Decision Makers With Decision Makers
