## Celebrating 20 Years of ILPA Summit New York!

The ILPA Summit New York is the organization's exclusive flagship event. This year marks the event's 20<sup>th</sup> anniversary of private equity professionals gathering to foster new relationships and strengthen long-term connections.

Qualified GPs and engaged LPs are scheduled to meet based on optimized preferences to ensure productive and mutually beneficial meetings. ILPA uses a proprietary algorithm created specifically for this event to match investment preferences and create custom meeting schedules. The three-day agenda also includes timely content sessions and networking.

General Partner registration will be limited to ~75 established managers and ~15 emerging managers.

## **GP Application Process**



All GPs must be pre-approved before registering. To join the invitation list and pre-approved for a future event, please complete the application on the website to be reviewed by the ILPA Summit Committee. If approved, your organization will be added to the invitation list.

Given the current fundraising environment, it is no surprise that the last few years we saw unprecedented demand and inbound inquiries for GP registration. Given the space constraints and requirement to provide a differentiated GP list that round out the participating LP's interests, we unfortunately cannot accommodate all the interest we would like to.

### Is the ILPA Summit a Fit for My Organization?

Before you apply for the ILPA Summit, please take a moment to determine if the Summit events are a fit for you.

- Are you an established manager or an Emerging Manager (raising a first or second fund or spinout of an existing fund)? Emerging Managers should apply for our <a href="Emerging Manager showcase">Emerging Manager showcase</a>. Established managers should apply for the main <a href="LEPA Summit New York">ILPA Summit New York</a>. (Applications for the New York event will open in early 2024)
- ILPA Summit events are <u>not a fit</u> for real estate-focused funds or real asset focused funds, very niche strategy focused funds or niche geographically focused funds are also typically accepted for participation at the Summit as we need to ensure that there is a match with the typical base of limited partner attendees.
- The manager applications that are focused on private equity, buyout, growth, private credit, secondaries and some venture capital are more representative of the GP participants at the Summit. Applications for strategies outside of the ones listed are not typically a fit as we want to ensure that we can build out a full schedule for selected GP participants.




# Summit NY Attendee Profile By Type: Diverse Strategies, Diverse Allocators


