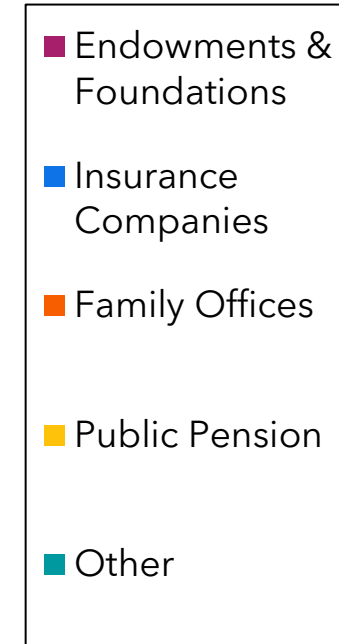
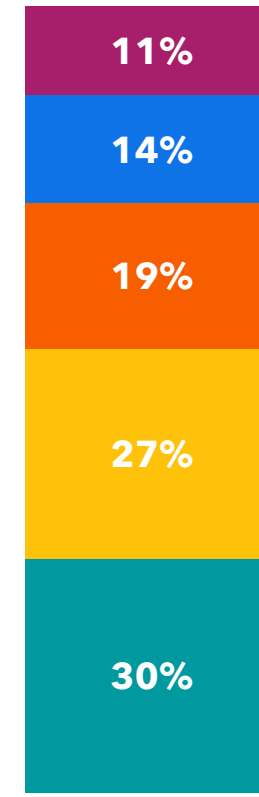
Summit Europe Attendee Profiles By Institution: Diverse Strategies, Diverse Allocators

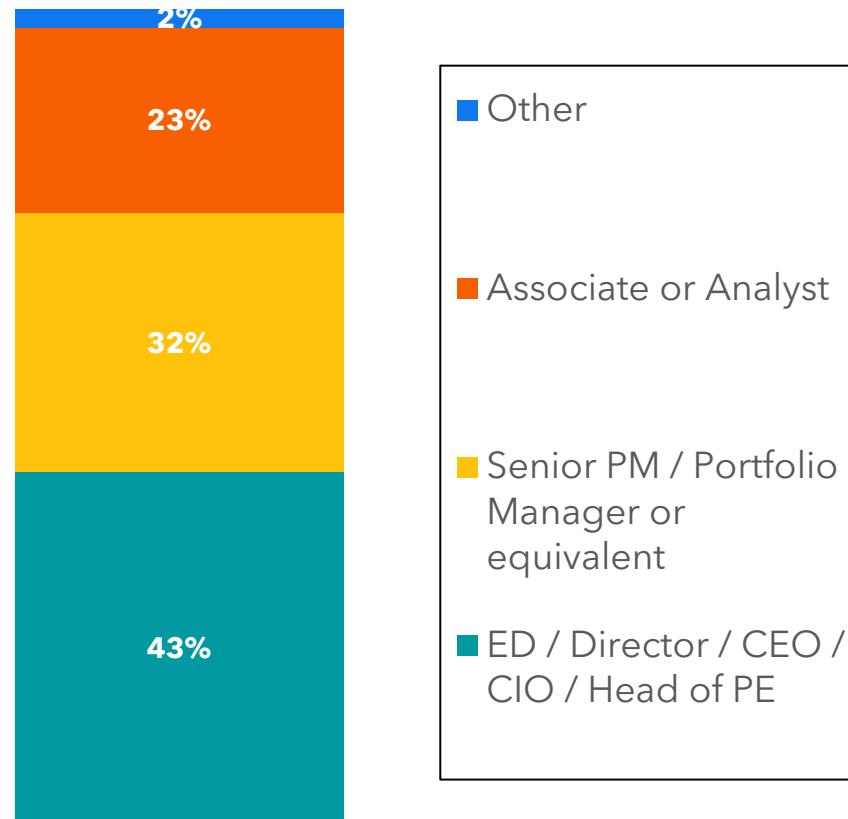

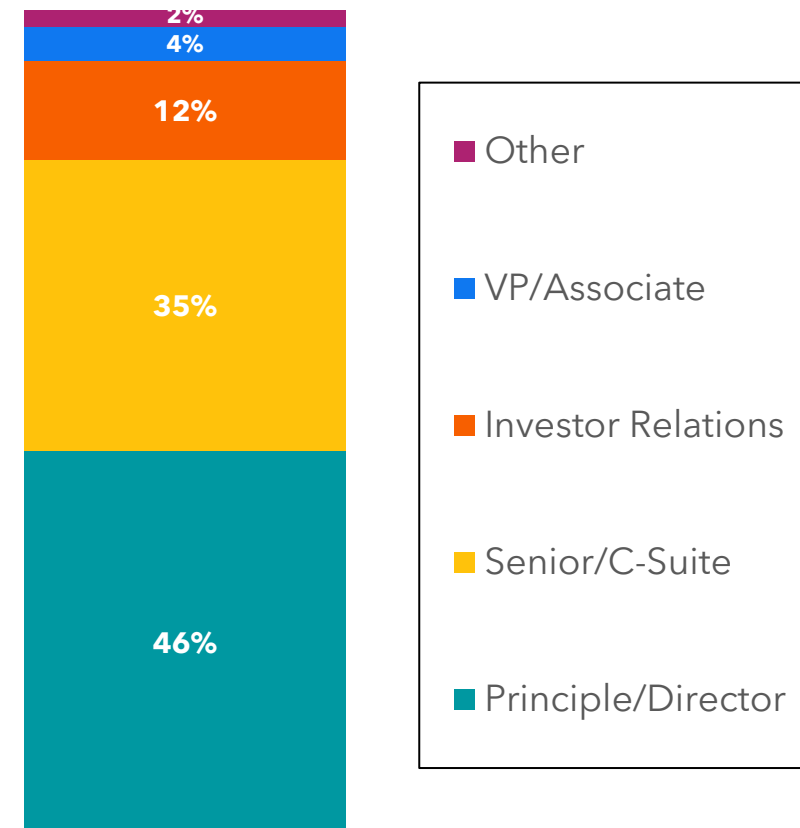
Summit Europe Attendee Profile By Role: Decision Makers With Decision Makers
