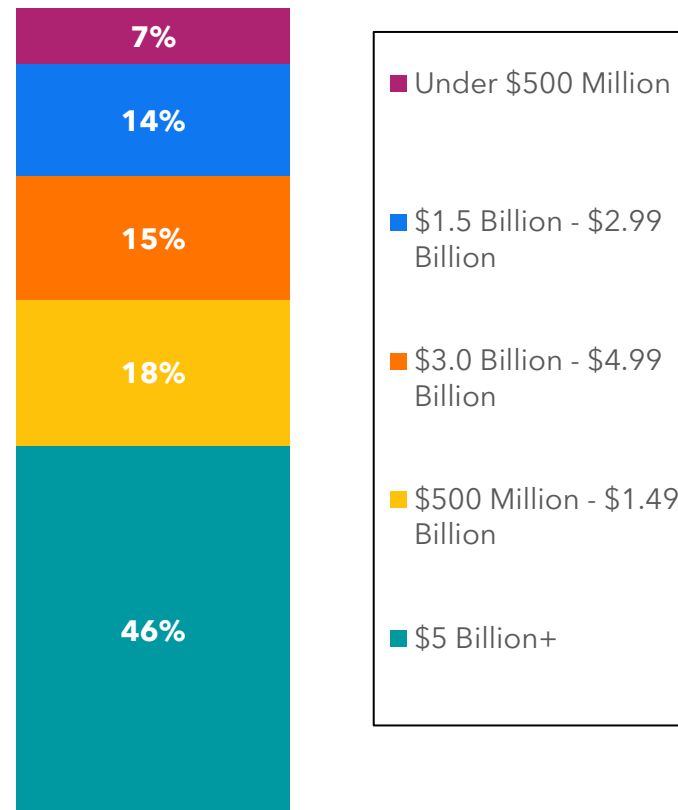
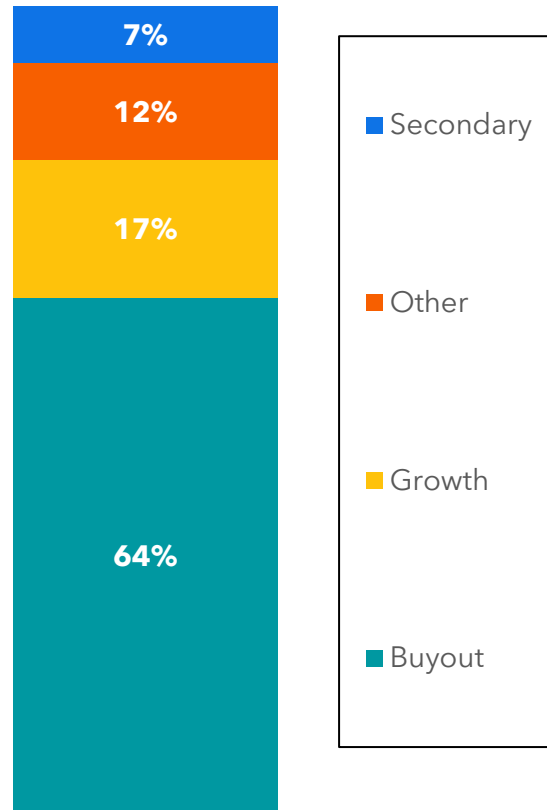

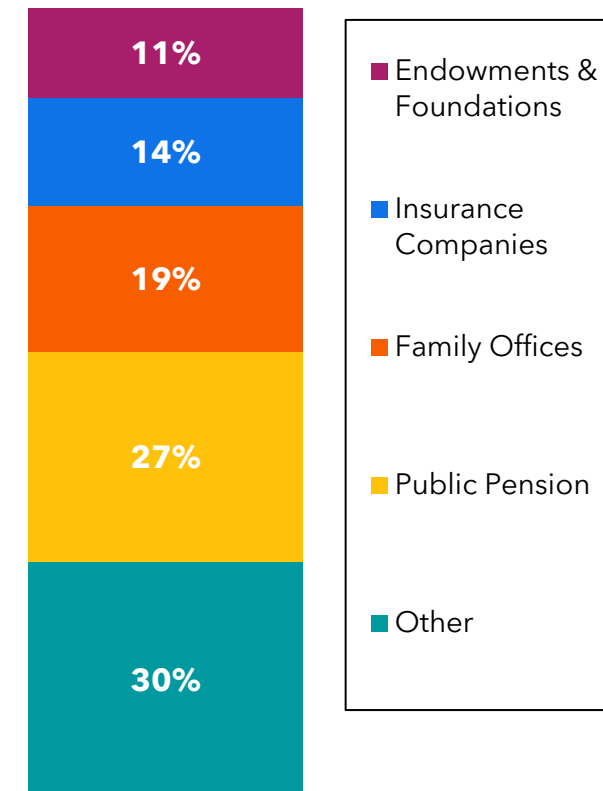
Summit NY Attendee Profile By Type: Diverse Strategies, Diverse Allocators



General Partner Institutions



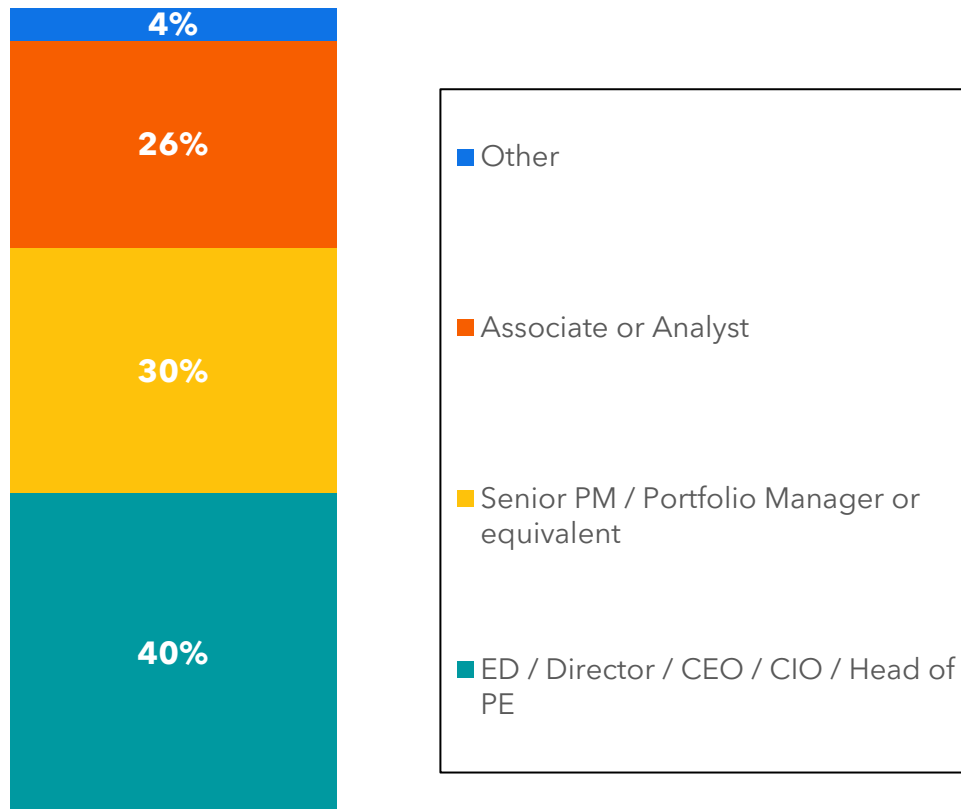
Limited Partner Institutions



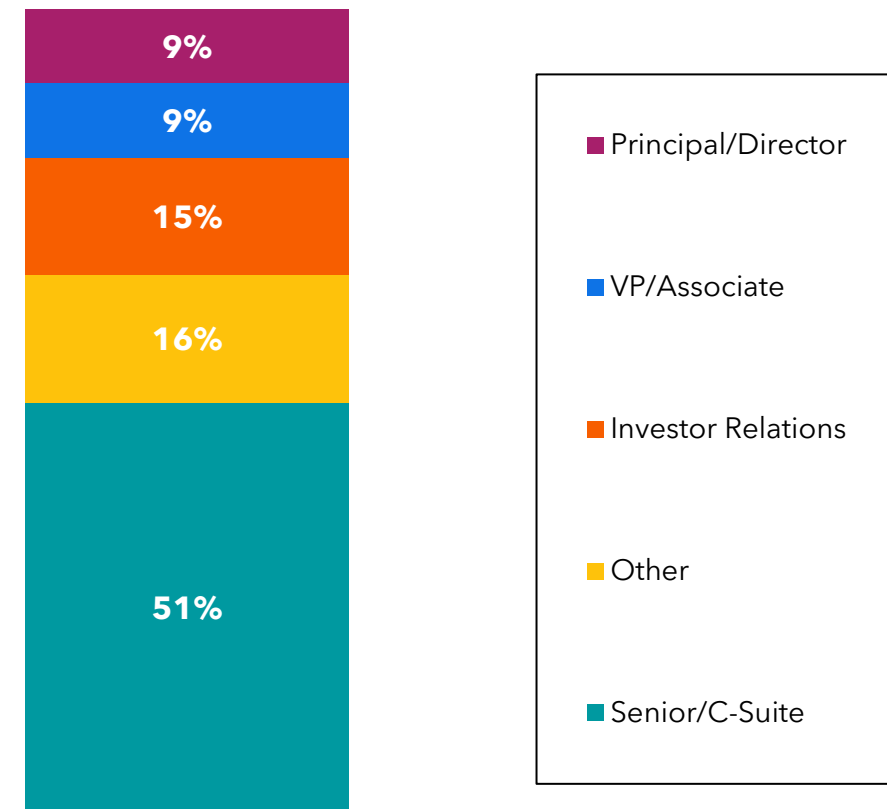
Summit NY Attendee Profile By Type: Decision Makers With Decision Makers
